About Joining Mediation Plus

Mediation Plus is a non-profit charitable community mediation organisation formed in 2006 as a result of the merger of the Wealden Independent Mediation and Eastbourne Mediation services. Membership is open to volunteers, interested persons, related professionals and stakeholder organisations and referring agencies.

Our purpose is to provide and facilitate a high-quality, impartial and confidential mediation service that enables and empowers individuals, groups and communities within our area to have the knowledge and understanding to resolve and prevent conflicts and disputes themselves.

The Charity's Objects are:

- i) To promote for the public benefit primarily in East Sussex and elsewhere, and with a view to preservation of public order, the provision of services directed toward Mediation and Conciliation between persons, organisations and groups who are involved in dispute or conflict which results from or may lead to acts of nuisance, vandalism, racial abuse, breach of the peace or family breakdown.
- ii) To advance the education of the public in methods of such mediation and conciliation and in particular the nature and causes of such dispute and means of managing it.

By becoming a member of Mediation Plus you agree to support the Charity's Objects and abide by our constitution. Membership is valid for 12 months from the date of acceptance and is renewable annually. Confirmation of membership will be via the issue of a membership card.

Why become a Member?

Membership of Mediation Plus provides both benefits and responsibilities. The benefits include having a say in the management and direction of the organisation. Members are an important constituent for the organisation, in attaining feedback about its work and performance. At the same time, members are expected to act responsibly to promote and support the organisation and its work.

Members are automatically entitled to attend and to vote at our Annual General or Special General Meetings and individual members are eligible to stand for election as Trustees to the Management Committee.
